4.5 Bus Purchases

- In 2015-16 the Board approved \$400,000 for purchase of new buses with plan to purchase one bus each year after. With \$48,000 left over, there is not enough for a new bus. A new bus will cost \$80,000-\$90,000. Transportation coordinator Mong Vang would like to purchase one pending board approval.
- Currently we have 2 spare buses, but one needs an engine. There are not enough spare busses.
- Chuck will look into the budget to determine if there is allowable funds to make this move.
- Kevin motioned to tabled bus purchasing until Chuck can work through the budget with Cha-Ger and Bao. Becky seconded. The motion passed unanimously.
